Sand & Salt Shed Readiness

Sand and salt sheds are at high risk for collapse because they are usually light construction, metal sheathing on wood or metal frame, or an arched rib metal structure without internal supports. Often such structure's integrity is compromised by being struck by equipment or by uneven vertical loading from snow sliding off one side, but not the other. Buildings can be protected by removing vegetation and snow from them and, perhaps, even more important in the case of Quonset or dome constructed sand sheds from around them. When snow is allowed to accumulate against the sidewalls, it prevents snow from sliding from the roof, causing it to pile on the roof and creating forces that may exceed design limits.

- Typical Hazards:
- Vegetation growth against sides of buildings
- Sand and salt stored against the walls
- Overfilling exceeding fill line
- · Rust and corrosion
- Displaced walls
- Foundation cracking

The design work includes factoring in snow loads, wind loads and other weather conditions. With that in mind, your building should have no issues handling typical snow loads. Unfortunately, things are not always "typical" and as a result, if you receive an unusually large snowfall, or allow snow to accumulate along the sides, then it is strongly recommended that you remove the snow.
